This is primarily achieved by taking steps in terms of labour and contract law, monitoring the contractual partners, implementing tax measures and making use of subsidies.

Contracts

- Examination of the specific contractual situation - (force majeure clause; withdrawal/suspension of services, deadlines, form; contractual penalties, risk, etc.).
- Is contract performance possible? What applies in case of debtor/creditor default? Can performance be refused? What has to be considered?
- Special regulations for transactions for delivery by a fixed date (e.g. events: effectiveness of GTC clauses vis-à-vis customers).
- Deferral agreements – which ones really postpone the due date?
- Is the basis of the agreement no longer valid?
- Monitoring of business partners, whether they are already (materially or formally) insolvent (avoiding unpleasant surprises, preventing the contestability of services/payments still to be made, securing information rights, offsetting possibilities).
- Special regulations for tenancy and lease relationships: new legal regulations, suspension of payments, reduction of rent/lease.
- Protection to secure liquidity within the group (subordination declaration, group guarantees, letters of comfort; shareholder loans, effects on cash pools, outsourcing of risk areas to limit liability within the group).
