

# Our recent experience

Here are some examples of our recent experience.

Employment litigation in the Banking & Financial Sector

We have successfully represented our clients (i) as defendants by having employee claims dismissed, and (ii) as claimants in actions to recover monies owed by employees.

Corporate restructuring & impact on employment

We have successfully advised our clients on the deployment of partial asset transfers and closing down activities: job displacement, redundancies, negotiations with staff representatives and authorities, and dealing with individual claims.

Key employee management We have successfully advised our clients on (i) arrangements to retain key employees in mergers, and (ii) handling situations involving unfair competition with mass layoffs of employees in key client-facing positions.

Compensation and benefits policy review

We regularly assist our clients with reviewing compensation and benefits policies, profit-sharing agreements, and in particular compliance with mandatory regulatory provisions in certain sectors.

Pre-acquisition due diligence

Staff representation litigation

Criminal liability risk management for employers




