1. Introduction

Juicy Holdings B.V., registered at the Dutch Chamber of Commerce (*Kamer van Koophandel, KvK*) under number 41216579 (**Juicy Holdings**), was declared bankrupt by the Amsterdam District Court on 4 November 2022.

In the context of Juicy Holdings' bankruptcy, the Amsterdam District Court appointed V.G.T. van Emstede as supervisory judge (*rechter-commissaris*) and M.N. de Groot as bankruptcy trustee (*faillissementscurator*).|

Due to an increased number of status inquiries from individual creditors, I would like to inform all creditors by means of this notice as follows. Please understand that I will not respond to individual, personal inquiries – due to the absence of any further available information.

2. Current bankruptcy estate

Contrary to certain circulating, incorrect information, the bankruptcy estate account currently shows a negative balance.

However, additional inflows into the estate cannot be ruled out and depend on the specific outcomes of numerous consultations with authorities in various jurisdictions.

3. Expected dividend

Based on the current assessment (as of July 2025), it is uncertain whether there will be any distribution to (unsecured) bankruptcy creditors in the final distribution.

Nevertheless, it is not excluded that a potential future inflow into the estate could still result in a small dividend in favour of the bankruptcy creditors at a later stage.

4. Duration of the bankruptcy proceedings

The conclusion of the bankruptcy proceedings, and thus the timing of any potential distribution, is currently unforeseeable.
