Berlin – CMP Fonds I GmbH, which is advised by Berlin-based CMP Capital Management-Partners GmbH, has sold its 100% stake in Regen-based Schock GmbH to EQUITA GmbH & Co. Holding KGaA, Bad Homburg, as part of a buyout transaction. The purchase price was not disclosed.
