Synergie International Employment Solutions SL, one of the largest personnel services providers in Europe, has acquired an 80-percent stake in the Austrian company Völker GmbH Personalbereitstellung. An international CMS team provided comprehensive legal advice to the buyer in the course of this transaction, which is still subject to approval by the competition authorities.

An international CMS team headed by lead partner Sibylle Novak (CMS in Vienna, corporate/M&A/tax) and Gerd Leutner (CMS in Berlin, corporate) advised Synergie on all legal aspects of the share deal. The transaction concluded, in which the sell side is made up of multiple parties, is based on a complex arrangement of rules covering the legislation in several countries.

Synergie SL is part of the Synergie Group, which has been active in the recruitment industry since 1969. The group operates more than 600 branches in 16 countries with over 3,000 employees. By acquiring a stake in Austrian Völker GmbH Personalbereitstellung, Sinergy will enter the rapidly growing Austrian market.

Völker GmbH is a temporary employment agency based in Austria. The company was founded in 2005 and can place a workforce of 1,500 people in 15 locations throughout the country.
