#### Detailed results for Austria and CEE

Apart from ranking law firms, IFLR1000 also looked at outstanding legal experts. For Austria, Bernt Elsner, partner and head of the public procurement law, EU competition law and public commercial law team as well as head of the CMS-wide Procurement Group, is mentioned. The ranking also recommends the services of Johannes Trenkwalder and Thomas Hamerl, who both specialise in public-private partnerships (PPP) and renewables, the latter field including solar, wind and biomass projects alike. Johannes Trenkwalder acted, for instance, as an advisor to the US company CWP (Continental Wind Partners) during the construction of the largest wind park in Serbia.

The sheer number of energy and infrastructure projects handled in the recent past is an indication of the standing of CMS Reich-Rohrwig Hainz in CEE. The law firm has advised the European Bank for Reconstruction and Development (EBRD) in the course of its energy efficiency programme in Bosnia and Herzegovina as well as in Montenegro and Serbia. It also supported the construction company Sano in its development of a biomass power plant in Bulgaria.
