Cologne – CMS Hasche Sigle has advised RAG-Stiftung Beteiligungsgesellschaft mbH on the acquisition of 70% of the shares in the Dorsch Group, supported by CMS Austria, CMS Dubai and legal teams from India, Egypt and Thailand.
