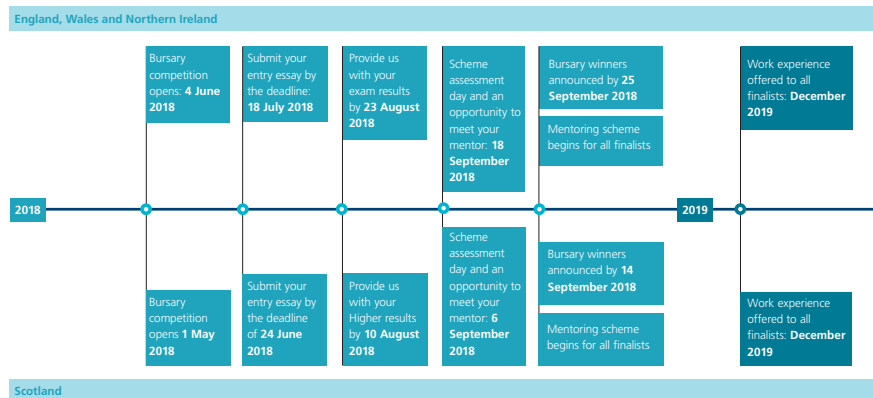

Who can apply



Our bursaries are open to Year 12/S5 state school and college students who want to study law at university, are expected to achieve at least ABB or equivalent at A Level or ABBB or AAB in Highers and are in the first generation to go to university.

You must also meet certain financial criteria, based on your personal circumstances or the number of pupils at your school eligible for free schools meals.

Applications are through our essay competition, which opens in May (Scotland) and June (rest of UK). We will also look at your academic results and references from your teachers. If we decide to interview you, we will invite you to an assessment day in London or Glasgow in September 2018.
