# CMS Advises Tyre Manufacturer Michelin on Acquiring Share in Autocentre Operator A.T.U

The French tyre manufacturer Michelin acquires a 20-percent minority share in the German autocentre operator A.T.U (Auto-Teile-Unger). An international CMS team of legal experts from Austria, Germany, Switzerland and France advised the clients throughout the transaction.

Michelin, a leading international producer of tyres, has entered into a partnership with Mobivia. With brands like Norauto and Midas, Mobivia is among Europe's leading automotive maintenance and repair services groups. As part of this partnership, Michelin acquires a 20-percent minority share in the German autocentre operator A.T.U (Auto-Teile-Unger) for EUR 60 million.

Throughout the transaction, an international CMS team of legal experts from Austria, Germany, Switzerland and France advised Michelin and Mobivia in questions of antitrust law.
