## St James Quarter

Delivering the largest urban regeneration project in the UK

To create a complex mixed-use investment of this size within a world heritage location has required an incredible effort from a highly skilled and talented team. CMS has been a major part of that team and their skill, experience and dedication have performed a central role in securing the investment and implementing the project.



St James Quarter, Edinburgh demonstrates CMS's position as key adviser on one of the largest and most challenging urban regeneration projects in the UK.

This retail led, lifestyle district provides a mix of restaurants, cafés, bars, shops, public spaces and leisure venues covering 1.7 million sq. ft. alongside Scotland's first W Hotel, a Roomzzz Aparthotel and 152 residential apartments all of which further strengthens Edinburgh's position as one of the most popular cities to visit in the world.

The regeneration project has been highly sensitive as it is located in an UNESCO World Heritage Site and involved demolition of a 1970s centre in the middle of Georgian Edinburgh and its replacement around a (remodelled and retained) John Lewis store.

CMS has advised Nuveen on the project since 2006. Over 200 CMS lawyers have now advised on different aspects of the project, delivering a seamlessly integrated service. With all of the development now open, teams across CMS continue to work on this complex mandate.

# Case study

## University of Glasgow

A Transformational Campus

We knew delivering a transformational campus expansion putting people at the heart of our thinking, in the midst of a vibrant and historic learning environment and research-intensive campus, surrounded by an active and engaged community was going to take time, agility and creativity and CMS have been with us, supporting on every step of our journey.



The University of Glasgow's (**UOG's**) Campus Expansion Project, launched in around 2008, is a transformative £1 billion initiative to enable the University's ambition as a world-class learning and research institution and UOG have been clear on their ambition for a holistic campus development, creating a place that is woven into the wider west end and ensuring the best experience for our students, staff and wider community. A place to learn, work, live, play. The Western Campus is the physical embodiment of this ambition.

A key element of the project was the acquisition, planning and redevelopment of a c.14-acre site, formerly the Western Infirmary Hospital, acquired from NHS. CMS is providing Real Estate and Construction advice for this ambitious project, working closely with UOG's Estates team and external partners. Additional specialist advice includes Procurement, Environmental, and Planning, in particular on the site's historic listed buildings.

# Case study

## The Culzean Floating Wind Pilot Project

Reducing emissions of offshore oil and gas operations



The Culzean Floating Wind Pilot Project aims to reduce emissions associated with offshore oil and gas operations through the provision of renewable electricity from a 3 MW floating wind turbine directly connected to the Culzean platform. The project is expected to be fully operational by the end of 2025, supplying around 20% of Culzean's power requirement, thereby reducing its greenhouse gas emissions. The turbine will be installed on a modular, light semi-submersible floating foundation, allowing for fast assembly and optimised costs.

CMS has advised TotalEnergies, who operate the Culzean field, on this innovative project. TotalEnergies, a longstanding oil and gas client, selected CMS as part of its panel of trusted advisers. This instruction demonstrates the confidence that the in-house team have in CMS to deliver a strategic decarbonisation project. The project required careful consideration of how standard practices in oil and gas project agreements could align with offshore wind generation projects.

As a pilot initiative, the Culzean Floating Wind Pilot Project is seen as an opportunity to demonstrate the potential of decarbonising offshore oil and gas operations by integrating renewable electricity generation. It represents an important initial step towards larger scale reduction in offshore emissions through the electrification of oil and gas assets, – consistent with the targets of the North Sea Transition Deal and the UK's net zero targets.
