Decision following the application submitted on behalf of the bankruptcy trustee *meester drs. J.L.M. Groenwegen* pursuant to Article 137(2) of the Bankruptcy Act (BA) to correct the official record of the meeting of creditors pursuant to Article 84 of the BA of 1 June 2018 in the bankruptcy of:

the private company with limited liability

PORTUGAL TELECOM INTERNATIONAL FINANCE B.V.

with its registered seat in Amsterdam

registered with the Chamber of Commerce under number 34108060

business address: 1043 BW Amsterdam, Naritaweg 165,

The bankruptcy trustee has requested correction of court record of the meeting of creditors pursuant to Article 84 of the Bankruptcy Act (BA) because the table on page 2 of the court record incorrectly refers to claims by BDO Audit & Assurance B.V., Citco Nederland B.V. and KPMG (Meijburg & Co Belastingadviseurs) exclusive of VAT. The claims must be shown in the table inclusive of VAT.

When comparing the court record of the meeting of creditors pursuant to Article 84 of the BA with the case documents, it became apparent that the court record contained an error, which should be corrected, and the decision should now be as follows.

DECISION

The district court:

- corrects the error in the court record of 1 June 2018 in such a way that instead of:
