### **Sustainable Orientation Wins CMS Reich-Rohrwig Hainz “Austrian Law Firm of the Year” at the JUVE Awards 2014**

**Once a year JUVE, the professional journal for business law, scrutinises the legal advice industry. Yesterday evening the JUVE awards 2014 were announced.
