Project description

International scientific seminars «Comparative Law: Current State and Prospects for Development» are held annually and attract attention of scientists, lecturers, practitioners and postgraduates. The participants of the Seminar were scientists from Ukraine, Russian Federation, USA, Turkey, Georgia, Belarus and Uzbekistan. On results of the seminars were published collections of scientific articles. The seminars work was highlighted by Ukrainian and foreign law periodicals.

The Comparative Law Days continue the tradition of holding international scientific seminars «Comparative Law: Current State and Prospects for Development» in 2006-2008, but have broadened conception. The Comparative Law Days is the complex scientific and educational action, which aim is to raise the level of participants skills, exchange of views on the most important problems of contemporary comparative law, familiarization with new scientific researches and publications.

- 3. Comparative law in the system of law education

April 9-10: <u>Open lectures (master-classes)</u> by known scholars within the scope of the Ukrainian School of Comparative Law project

April 10-11: <u>Scientific conference "Comparative Law Discussions"</u> Sections:

1. Supranational tendencies in the development of law branches and institutes (subsections: constitutional and municipal law, administrative and financial law, civil law, criminal law).

- 2. Comparative investigation in international and European law
- **3.** Theory of law and comparative law
- 4. Comparative studies of legal history
- 5. Ethics of lawyer: foreign experience for Ukraine

April 8-11: <u>Presentations of projects of Ukrainian, foreign and international organizations</u> April 8-11: <u>Presentations of books and journals</u> on comparative law, legal theory, international and European law.

The **exhibition of legal editions** of Ukrainian publishing houses will be organized and the authors will have possibility to present or sell their editions.

Organizers will provide a **cultural program.**

Working languages of the seminar – Ukrainian, Russian and English.

The participants of the Comparative Law Days will get **certificates**. The texts of open lectures, reports and discussion speeches will be published.

All materials of the Comparative Law Days will be published in Internet on the site <u>www.comparativelaw.org.ua.</u>

Participation:

The participation in the international scientific seminar is free of charge. Possible forms of participation are report (to be agreed with Organizational Committee) or speech. The text of report – up to 10 pages (20000 symbols) or speech – up to 5 pages (10000 symbols). The participants of the seminar may visit open lectures free of charge. Participation of students is not provided.

The participation in the scientific conference can be with real attendance or distant. It provides the possibility to take part in plenary and sectional sessions, visit open lectures and publication of thesis of speech. The participation in the conference is free for specially invited. Others pay registration payment (30 USD). Thesis of speech – to 5 pages (10000 symbols).

Also possible are book or project presentation, organizational, informational, sponsor participation. Travel, accommodation and board are participant expenses.

The deadline for applying – **March 25, 2009.** Application has to be sent by e-mail, mail or fax and contain next data: first, middle and last name; degrees and honors; organization, job position; form of participation; topic of report or speech; contact address, phone, fax (optional), e-mail; the need for accommodation; date of arrival and departure.

Organizational Committee booking rooms in hotels on requests for participants whom request would be received till **March 25, 2009.** The variants and prices of staying in hotels will be available in the Internet (on site www.comparativelaw.org.ua).

Applications for holding presentations of monographs, books, annuals, scientific journals, legal newspapers, projects etc. and also applications for participation in law books exhibition are to be sent by authors or organizations till **March 25, 2009** with appropriate materials (annotation, table of contents, photo of cover – for printed editions; description – for projects; list of books – for participants of exhibition).

- not corresponding to topics of round tables and sections;
- not corresponding to scientific level of Comparative Law Days;
- out of mentioned above volume.
