# Cartels, Dawn Raids and Competition Investigations

Acquisitions and disposals of shares or assets, trade marks, as well as the creation of joint ventures can require regulatory approval either at a national level from the relevant national merger control authorities or at EU level from the European Commission.

We have vast experience of the practicalities of dealing with national competition authorities and the European Commission's services, enabling us to lead clients safely through the maze of formal and informal processes.
