- All students invited to interview will be offered mentoring support from one of our lawyers for their university application, support from one of our graduate trainees and work experience at CMS during their first year of university.

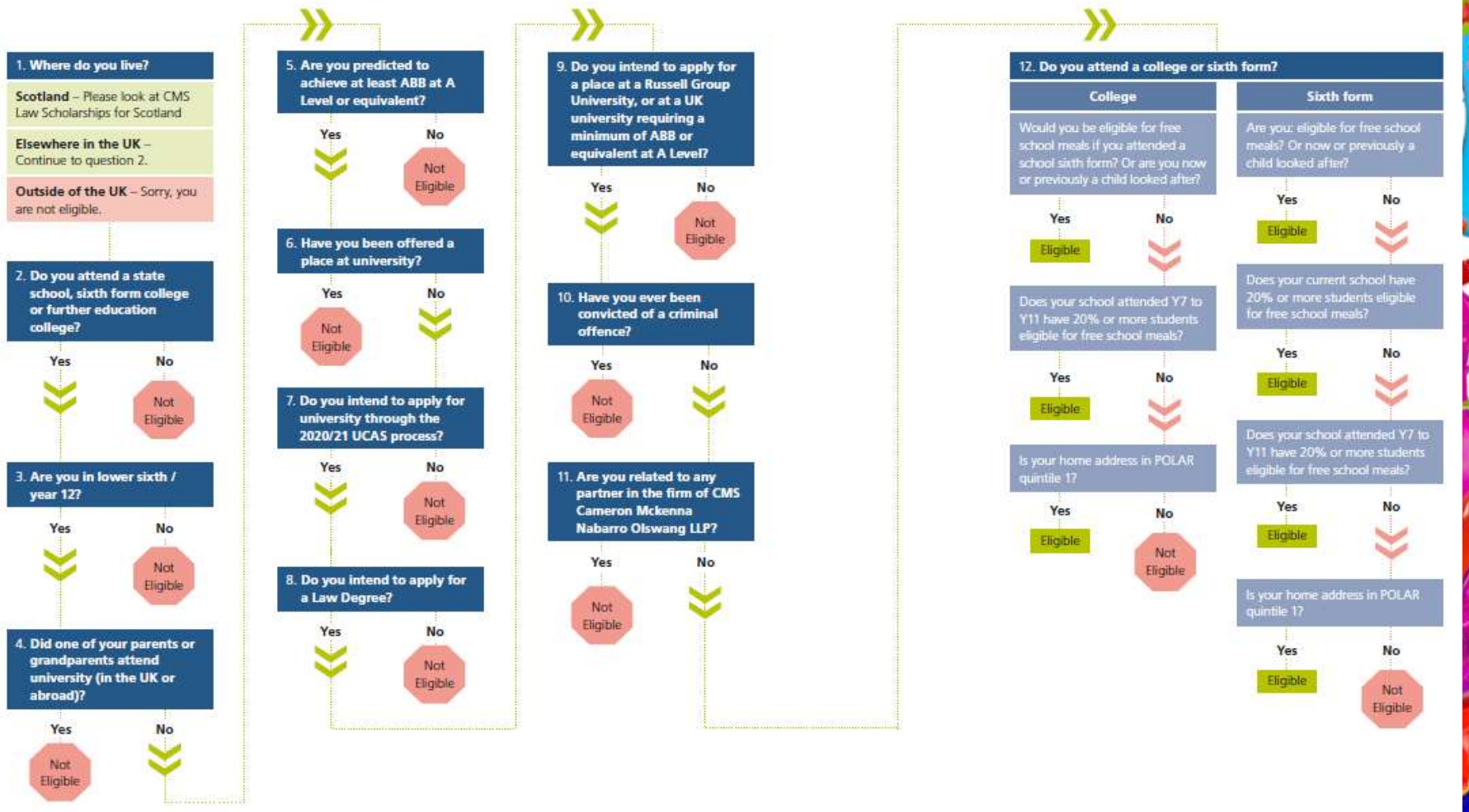


What do you need to know about CMS?

How do I apply?

- To be considered for a scholarship, you will need to enter our essay-writing competition which opens on 15 June and closes on 22 July.
- The essay questions to choose from for 2020 are:
 1. Will the current lockdown create more advantages than disadvantages?
 2. “Until climate action becomes profitable, positive climate change will not happen.” Do you agree?
- Essays must be between 750 and 1000 words. You can find out more on our website.



How do I apply?

- If you do well, we will interview you at our London offices on 22 September 2020, giving you the chance to meet trainee solicitors and take part in fun team building exercises.
- If government advice means we cannot interview you in person, we will host a virtual assessment day.
- Travel and accommodation (for you and your accompanying adult) will be arranged and paid for by us.
