#### What is a Health & Safety incident?

A Health & Safety incident includes:

- Industrial accident/occupational diseases (severe accident at work, RSI, mesothelioma, etc.)
- Environmental incidents (contamination, fire, asbestos, etc.)
- Impending product-recalls (food, medical devices, etc.)

### An incident, next steps?

When a company is faced with a severe incident, inspectors from the concerning supervisory authority (for example the Social Affairs and Employment Inspectorate *or* the Food and Consumer Product Safety Authority) will often visit unannounced at your premises for inspection. The choices the company makes in this stage are often crucial. The concerning supervisory authority has far-reaching powers (such as attachments, questioning, information request, order a recall, etc.) which require a quick and adequate response. Furthermore, the underlying interests of the corporate liability insurer cannot be neglected. Immediate advice and support is of the utmost importance. At this stage, the incident can no longer be prevented but the (financial) consequences can be controlled.

Our strategy is aimed at minimalising the negative consequences, including the loss, and, as quickly and effectively as possible, to find the best solution. When beneficial to the case, and in consultation with you and/or your insurance company, we engage the help of third parties, such as loss adjusters, forensic technicians and communication advisers.

- Possible options of recourse will be secured.

- o Fatal accident at a multinational in the chemical industry. The Public Prosecution Service and the Social Affairs and Employment Inspectorate did not institute criminal or administrative enforcement. The civil claim was dropped.
- o Advice and assistance to a company in the construction sector about cross-border discharge of waste (European Waste Shipment Regulation). The case is dismissed.
- A company in the construction sector and a manager 0 were accused of various environmental incidents and violation of various health and safety regulations which were included in the permit. Clients were acquitted.
- 0 Put up a successful defense against an administrative fine relating to an accident on a sports event. The civil claim was subsequently also dropped.
- Advising and litigating on behalf of a manufacturer of medical devices, who was held liable by various patients for the alleged defective products. The case is still pending.

- Defence for a company in the automotive industry against a fine notification of the Employment Inspectorate in response to an accident. The defence was successful and the civil claim was dropped;

- o Successful defence in various asbestos claims by employees;
- o Accident at a construction site, where a bystander was deadly injured. Criminal and civil representation of a large construction company. Case is still pending;
- o Legal assistance to (the insurer of) a vegetable processing company in connection with a deadly accident involving a forklift truck. Case is still pending.
