CMS Hasche Sigle advises Kalle Group management on exit and reinvestment

Stuttgart – The Kalle Group management team has sold its stake in the company against the backdrop of a change in private equity investor. Silverfleet Capital Partners acquired the holding in Kalle from Montagu for EUR 212.5 million. Kalle's management reinvested at the same time as Silverfleet Capital Partners took over as the new private equity investor.
