Wind farm in Brandenburg: CMS Hasche Sigle advises BKW FMB Energie AG

Stuttgart – Swiss energy company BKW FMB Energie AG has acquired another wind farm in Germany, scheduled to be operational by the end of 2010. The 20 wind power plants have a total installed capacity of 40 MW.

Construction of the Dubener Platte wind farm in Luckau, in the Federal State of Brandenburg, is already under way.
