Stuttgart – Switzerland's largest construction group, Dietlikon-based Implen AG, has bought the infrastructure division of Bilfinger SE. The transaction is currently awaiting approval from the competition authorities.

A team led by lead partner Dr Thomas Meyding advised Implen AG on all aspects of the transaction.

The infrastructure division has a production output of around EUR 650 million and some 1,850 employees.
