### CMS Hasche Sigle advises Invesco on acquisition of Westside Tower development project

Munich – Invesco Real Estate (IRE) has acquired the Westside Tower development project in Frankfurt/Main from Revitalis Real Estate AG. The 21-storey tower block comprising some 250 rental apartments and a total area of around 26,000 sq m is under construction on Europa-Allee in Frankfurt's Europa district, one of the largest inner-city building projects in Germany. Completion is expected by mid-2015. The purchase price was not disclosed.
