ThyssenKrupp elevator division advised by CMS on acquisition in England

Düsseldorf – The Elevator Technology division of Essen-based engineering group ThyssenKrupp has acquired Lift & Engineering Services Ltd. (LES) of Cradley Heath in the UK's Midlands. The acquisition of the family-owned business is part of ThyssenKrupp's plans to expand its global service business against a backdrop of increasing urbanisation. The purchase price was not disclosed.
