History of CMS in Germany

CMS in Germany is part of the international CMS organisation of law firms. It is the result of a number of mergers that brought together law firms with strong regional roots, initially within Germany, followed by international expansion.

— **1990: Weiss & Hasche**

Merger of Ott Weiss Eschenlohr (Munich) and Hasche Albrecht Fischer (Hamburg).

Merger with Sigle Loose Schmidt-Diemitz & Partner (Stuttgart).

Establishment of international CMS organisation of law firms.

— **1995: Hasche & Eschenlohr**

The firm is renamed after the departure of Munich partner Dr Karl Heinz Weiss (son of Dr Karl Weiss).

— **2000: CMS Hasche Sigle Eschenlohr Peltzer Schäfer**

Merger with Schäfer Wipprecht Schickert (Düsseldorf).

— **1997: Hasche Eschenlohr Peltzer Riesenkampff Fischötter**

Hasche & Eschenlohr merges with Peltzer & Riesenkampff (Frankfurt/Main) and Fischötter Micheli & Partner (Hamburg).

— **2001: CMS Hasche Sigle**

Name shortened.

— **1999: CMS Hasche Sigle Eschenlohr Peltzer**

Merger with Fiedler & Forster (Frankfurt/Main, Munich).

— **2005: Growth in Cologne**

The Cologne office of Norton Rose joins CMS Hasche Sigle.
