Subject	CMS advises ADS-TEC on cooperation agreement

ADS-TEC successfully advised by CMS on cooperation for remote maintenance solutions with Weidmüller

Stuttgart – ADS-TEC GmbH of Nürtingen has signed a cooperation agreement with Detmold-based Weidmüller Interface GmbH & Co. KG in relation to remote maintenance solutions and cloud services. The start of cooperation is still subject to competition law approval from the Federal Cartel Office.
