Romania's largest photovoltaic park to date (45 MW) is being connected to the grid. The international law firm CMS Reich-Rohrwig Hainz advises the developers Green Source and LSG GROUP (the latter also acts as building contractor and project developer) as well as the park operator Alpha. The total investment volume amounts to EUR 100 million.

Even though the photovoltaic industry is in economic turmoil around the globe, it has experienced a small boom in Romania since the end of 2011. In Giurgiu, located south of the capital Bucharest, the 45-megawatt photovoltaic park is being connected to the grid.

CMS provided legal advice on Romania's largest photovoltaic project to date. CMS already supported the developer Green Source and the building contractor and project developer LSG GROUP in 2012, when a Korean conglomerate acquired the majority of shares of the photovoltaic park.
